At the outset, the Chairman welcomed the members present. The Director apprised the Board about current NIRF ranking of the Institute. The Institute secured 24th place (20th in 2017) in the Category of Engineering and 69th place (83rd place in 2017) in overall. An analysis on different parameters of rating is being carried out to make sure that the ranking of the Institute stood improved in the next year.

Open House discussion should also be encouraged to get an exhaustive feedback.		
		A comprehensive survey form should be designed covering all aspects of student life at IIT Patna.		
	ii. A percentage of seats for Industry sponsored students may be fixed.	ii. Sponsored students should be allowed from all organizations and not only from the Industry.		

	iv. For placement in larger number, a completely revamped program incorporating the methodologies for getting success in interviews etc needs to be design. An assessment on language skills of the students should also be carried out throughout the year	iv. In order to have an industrial exposure, the industry visit of students followed by a report, may be made mandatory. This may be taken up in the next meeting of the Senate. Students, it may be noted, however, are doing internship in large number.

While discussing the recommendation made by Senate, Hon'ble Board urged the Institute to review the recommendation made on scholarship to be paid to a Ph.D student during academic leave of long duration (6 months to 1 year). The senate had recommended (i) not allowing getting money from two sources (institute scholarship and stipend at the organization being visited) and (ii) giving the scholarship only for first three months, if the student is not getting money from any other source. Making a reference to faculty sabbatical wherein the faculty member gets both institute salary and remuneration from the place they visit, the Board desired examining the possibility of continuance of the scholarship even when the student is away on academic visit.

With above the above observation, Board approved recommendations of the Senate.

While appreciating the efforts put in by the Institute in drafting an exhaustive RR and PP policy, the Board desired addressing the following lacunae:

(a) promotional ladder from Group B to Group A without acquiring higher qualification,

- (b) different designations for 3^{rd} advancement and entry level posts, even though both are in the same pay scale, and
- (c) adoption of eligibility criteria different than what has been prescribed by UGC for Library and Registry etc.

The Board requested Dr. S.K Bhattacharyya and Dr. Amitabha Ghosh, members of the BoG, to provide their inputs in resolving the above and any other issues. Associate Dean (Admin) and the Registrar, IIT Patna will fix a meeting with nominated BoG members at Kolkata for this purpose. The policy so finalized, will be submitted to the BoG for approval by way of circulation.

Keeping in view the growth in terms of students, faculty and manifold increase in the activity of the Institute after its relocation to the permanent campus, the Board agreed to sanction additional 61 non-faculty administrative positions, with the condition that the Institute will conform to the standard ratio of 10:1:1 of student vs non-faculty.

Realizing the fact that additional strength so approved is the projection of requirement for next 3-4 years, Board empowered the Director to fill the posts in appropriate administrative category in Govt. approved pay scales as per the need of hour, subject to overall ceiling and adherence to the prescribe ratio of the 10:1:1

Considering the need of regular monitoring of ongoing and new works, the Board approved the engagement of Shri B.K Sahoo, Superintendent Engineer, IIT Kharagpur on the same terms and conditions, and remuneration offered to him by IIT Indore. The Board, however, advised the Institute to approach Mr. Subrato Roy of NITTTR, Bhopal to explore if he can offer consultancy services for IIT Patna.

Board accorded its approval to Cloud hosting of ERP solution through the private cloud approved by Ministry of Electronics & Information Technology, Govt. of India.

Privacy issues need to be addressed while migrating the legacy data of the Institute on to a common data base. Board approved the proposal to migrate the Institute data to ERP system through system implementer, with the instruction to insert suitable clauses in RFP document on data security and right to confidentiality.

Hon'ble Board expressed its concern on various clauses of the MoU to be signed between the Institute and KV Sangathan, observing that the MoU was one sided. The Institute will not have any say in the recruitment and posting of the teachers and staff; nor is the KV Sangathan willing to admit wards of interested employees; both these, despite the fact that the entire funding (Capital and operational) has to be borne by MHRD/IIT Patna.

Before proceeding further, the Board desired to get clarification from KV Sangathan on above points.
