## निषेध आदेश / Debarment Order

Whereas, with reference to the letter No. IITP/ADMIN/HR/2022/04/1189/1448 dtd. 17<sup>th</sup> November, 2022 **M/s Alankit Limited, 205-208, Anarkali Complex, Jhandewalan Extension, New Delhi-110055** had supplied Human Resources at IIT Patna on outsourced basis initially from December 2022 to November 2023 and subsequently extended upto August 2025 in accordance with tender No. IITP/ADMIN/HR/2022/04/1189 dtd. 19.09.2022 Annexure- C (Period of contract) and para No. 1 of mutually agreed contract. Firm continued to default the timely disbursal of monthly wages to the outsourced manpower deployed by them at IIT Patna.

Whereas, M/s Alankit Limited did not streamline the disbursal of monthly wages to outsourced manpower deployed by them at IIT Patna despite repeated reminders through emails & written communications.

Whereas, final warning for non-payment of wages and possible contract termination was sent to the firm vide IITP/R/Manpower/2025/42 dtd. 26/06/2025 and later, vide IITP/RO/2025/44 dtd. 07/07/2025 followed by e-mail reminders to the firm to release the due payment for the last 03 months to outsourced manpower deployed by the firm at IIT Patna failing which IIT Patna would blacklist the firm with wider circulation.

Whereas, the firm has failed to perform the contract in terms of timely disbursal of monthly wages and has failed to comply the tender clause No. 5 of the general condition of contract.

Whereas, the firm has failed to fulfill its contractual obligations as defined in the clause No. 03 subclause-iv of the mutually agreed contract conditions, causing hardship to the deployed manpower.

Therefore, in view of the above facts, continued non-compliance and violation of cited tender/contract conditions, M/s Alankit Limited is hereby **blacklisted from participating in any bid/tender of IIT Patna for a periods of 02 years w.e.f. date of issue of this order.** Further, the amount ₹ 9,00,000/- (Rupees Nine Lakh only) retained as Performance Security Deposit against the referred contract dtd. 17<sup>th</sup> November, 2022 stands forfeited in accordance with the conditions No. 14 (iv) of the aforementioned tender. The last extension of contract granted vide IITP/R/Manpower/2025/1581 dt. 12/06/2025 with clause of extension upto 31<sup>st</sup> August, 2025 or till selection of new service provider stands withdrawn with immediated effect.
