### Merit-cum-Means Scholarships

Applications are invited in the prescribed forms from the under graduate students of 2021, 2022, 2023 & 2024 batch (B. Tech./B.S. Programme) and 2023 & 2024 batch (M.Sc. Programme) for award of Merit-cum–Means scholarships in the academic year 2024-25 by the Institute.

### MCM Scholarship for the Undergraduate Students:

### For General & OBC category students:

- ₹ 1,000/- per month for two semesters (8 months in a year) = Total ₹ 8,000/-
- Free Tuition Fee

### For SC & ST category students:

- Free Messing ( Dues of only basic menu)
- Exemption from Hostel Room Rent
- Pocket allowance of Rs. 250/- per month (8 months in a year) = Total ₹ 1,000/-

### **Eligibility**

Merit: For General/EWS and OBC category students

For new entrants (B.Tech. /B.S. / M.Sc. first Year):

Their first Semester Performance Index (SPI) will be the criterion for their merit. In case of a tie, their JEE (Advance) – AIR (B.Tech First Year) / JAM –AIR (M.Sc. First Year) will be also considered.

The minimum SPI is 6.5 and no "F" (Fail) grade/s in any of the courses in their first semester. #

### For the students in the second year (B.Tech./B.S./M.Sc.) onwards:-

The minimum CPI is 6.5 and no "F" (Fail) grade/s in any of the courses. #

For the students in second year (B.Tech/B.S.M.Sc.) onwards:

No "F" (Fail) grade/s in any of the courses. #

# Important note: If a student has cleared a course subsequently through supplementary exam/make-up exam/repeating the course, s/he may be considered for MCM but the latest transcript issued on the basis of the result declared in December 2024 should not reflect "F" grade in any course. However, students having "F" grade in extra academic activities like NCC, NSS, NSO, etc. may apply for MCM. The students must enclose only the latest transcript, signed and sealed by the academic section of IIT Patna.

### Means:

### For all category students:-

- 1. Income certificate issued by the competent authority, not below the rank of Tehsildar/equivalent. (NOTARY certificate OR Income Tax Return, etc will NOT be accepted).
- 2. The income of both the father and mother will be taken into account.
- 3. According to current Govt. of India rules, students whose combined parental income is below Rs. 4.5 lakhs per annum are eligible to be considered for these scholarships. It should be noted that the parental income limit is subject to change from time to time as per GOI order.
- 4. Annual income of a student's parents/guardian and his family from all sources must not exceed Rs. 4.5 Lakhs. Valid income certificate must be issued on or after **01.04.2023**.

#### PLEASE NOTE:-

- The Google doc. must be filled as well as hard copy of the application, along with relevant enclosures must be sent to the Student Affairs Office.
- The application will be accepted only when Google doc. is correctly and completely filled and signed hard copy of the application along with all relevant enclosures are received in the SA office by the due date and time.
- Link for google doc. shall be shared separately through email.
- Income stated in the application form and google doc. must be the same as in the supporting document. Any discrepancy can attract disciplinary action including but not limited to revocation of scholarship.

In case a student is awarded any other scholarship/Stipend in future, s/he must intimate the same to Student Affairs Office and shall refund the entire amount of the MCM scholarship before receiving the other scholarship for the concerned year.
- Students must inform their parents/ guardians about their application for MCM scholarship.
