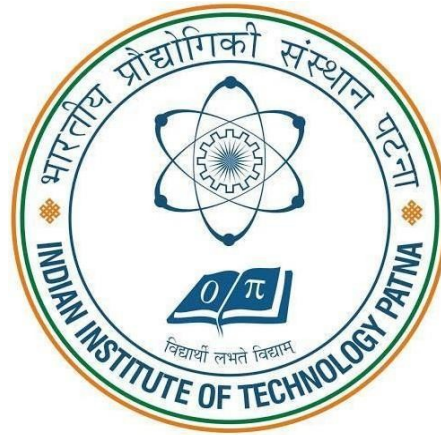

4. **The interested Firms are not required to deposit any tender fees.**

6. **Bidders need not come at the time of Technical as well as financial bid opening at IIT Patna. They can view live bid opening after login on CPP e- Procurement Portal at their remote end. If bidder wants to join bid opening event at IIT Patna then they have to come with bid acknowledgement slip that generates after successfully submission of the online bid.**

TECHNICAL BID

The Firms are also required to upload copies of the following documents:-

- (a) Scanned copy of Receipt of the Earnest Money Deposit (EMD) / its exemption, if any.
- (b) Scanned Copy of GST No. and Scanned Copy of PAN Card.
- (c) Scanned copies of work order and experience certificates as per the technical criteria of tender document.
- (d) Scanned Copy of Audited Annual Accounts for Financial Years 2018-19, 2019-20 and 2020-21. Average Annual Turnover for last three financial years i.e. 2018- 19, 2019-20 and 2020-21 should not be less than 50 % of the estimated cost & Should not have incurred any loss in more than two years during the immediate last five consecutive financial years, ending 31.03.2021.
