The aim of IIT Patna Alumni Association is to develop superior relations among the alumni, students, staff and faculty of the institute. The prime objectives of the Association are as follows:

- To bring significant development in the infrastructure and framework of the Institute.
- To facilitate information exchange among all who are directly/indirectly involved in the activities of the institute.
- Better coordination with the media for working towards the upliftment of one and all associated with the Institute.
- Exalting the standards of teaching and research activities at the Institute.

A Detailed presentation was made by the Dr. Anirban Chowdhury, PIC-Alumni before the Board.

The Board approved the Bye-laws with following observations:

- i. The name of the Association may be changed to 'IIT Patna Alumni Association' in place of 'IIT Patna Global Alumni Association'.
- ii. To begin with, the office bearers may be chosen by nomination and the association be got registered under Society Registration Act 1860, as a non-profit organization.
- iii. A token membership fee of Rs. 1000/- (Rupees one thousand only) per member may be fixed.
- iv. Application for seeking 100% IT exemption for donations/financial assistance given to the Alumni Association may be submitted to the appropriate authority, once the association is registered as a society.

In 27th meeting of the Hon'ble Board of Governors of the Institute, held on 6th April 2018, following was considered and approved:

"Recommendation of IPR Committee for adopting the 'Technology Transfer Rules & Guidelines' of IIT Bombay has been accepted by the Hon'ble Board, till IIT Patna frames its own guidelines."

In line with above, the following guidelines have been taken from "The Intellectual Property (IP) Policy of IIT Bombay".

"External Funded / Collaborative Development:

For the relevant invention(s) including software, designs and integrated circuit layouts, produced during the course of a sponsored and / or collaborative activity (internal / external), specific provisions related to IP made in contracts governing the collaborative activities are to be referred along with this policy. Cases where confidential data and results are to be used by the Institute for its academic and research work, exclusive access to the relevant project members have to be provided. Relevant faculty, students and researchers who would contribute in such projects are to be duly notified of potential delay in approval for publication, academic and research related activities before accepting such project proposals. Based on such agreements as signed by IIT Patna, the following scenarios are envisaged:

- 1. IIT Patna is the sole owner of the IP generated from the funding provided.
- 2. The IP generated is owned jointly with the collaborative partner having the first rights of refusal towards commercialization.
- 3. In the case of a collaborative / multiple consortium based IP generation, the IP terms of such agreement is to be considered along with the policy. In absence of any specific IP agreement in such cases, IIT Patna follows its IP policy.
- 4. IIT Patna can assign the IP generated, to the funding agency based on the nature of the technology, funding and specific applications.
  Under all circumstances, IIT Patna always reserves the right to use the IP generated for its academic and research purposes."

The Board approved the above proposal.

Comments of MoE: May be considered.

Before 2018, at IIT Patna, appointments on non –faculty positions were being made on contract of 3/5 years, after which the employees were confirmed in their posts following due process, based on satisfactory performance. This condition of likely confirmation after the contract period is over was explicitly mentioned in respective vacancy advertisement. The principles of transparency and open and fair competition were never violated, since the applicants knew right from the advertisement stage (No. IITP/RECT./002/2016 dated 17.08.2016), like in case of probation- that confirmation will be done based on performance. In their offer letter too (Clause 01 of offer letter no. R/IITP/RECT./2017/133 dated 01.03.2017), condition of confirmation/regularization was mentioned. From 2018, the institute shifted completely to probation based appointments.

In line with the condition of confirmation mentioned in advt. and offer of appointment, people taken on board were confirmed with the approval of Chairman

BoG subject to satisfactory performance evaluated by committee as per BoG approved procedure. Such confirmations were also got ratified in subsequent meetings of the BoG.

While ratifying 02 such cases of confirmation in its last meeting held on 10<sup>th</sup> October, 2020, the BoG directed to take legal opinion on the process adopted by the Institute before remaining similarly placed cases are taken up for confirmation.

The legal opinion of the advocate was placed before the Board.

A view citing Hon'ble Supreme Court's decision in case of Secretary, State of Karnataka vs Uma Devi is attracted in this matter, was expressed by Prof. Yogesh Singh, Member, BoG, prior to finalizing confirmation cases.

After due deliberations, the Board decided to seek the advice of two senior advocates/experts in service matters.

**Comments of MoE**: IIT Patna is advised to ensure that there are no legal complications at a later stage and the interests of IIT Patna are safe guarded.

It has been proposed to enter into an agreement with GAIL for supply of Piped Natural Gas (PNG) to the residential complexes, hostel mess, canteens, admin. building etc. In case of domestic connections, the agreement shall be executed between individual user and GAIL, whereas in case of commercial connections at Hostel Mess, Canteens, Night Canteens, Guest House kitchen etc., the agreement shall be signed between IIT Patna and GAIL. Detailed proposal as received from GAIL was presented before the BoG.

A piece of land measuring 15 x 25 sq. m, away from residential zone and near to the approach road is required to be allocated to GAIL for development of DCU/DRS/Cascade. Rent at prevalent rate, i.e. Rs. 4.00 per Sq. Ft, was proposed to be charged from GAIL subject to revision from time to time.

The Board agreed that setting up a PNG unit on campus would benefit the residents of the Campus and hence approved allocating the land measuring  $15 \times 25 \text{ sqm}$  to M/s GAIL with the direction to charge the rent as per GoI norms, in addition to electricity charges.

**Comments of MoE**: The Institute may ensure that the necessary action is in line with GFR 2017.

In 2018, Bids were invited through open tender for awarding fresh contracts to run House Keeping and Security Services of the Institute. On account of using forged documents in NIT No.: IITP/Admin/ Cleaning Service/02/2018 dated 19.08.2018, M/s. Biswas Security Services (India) Pvt. Ltd. was blacklisted for five (5) years vide

Letter No.: IITP/Admin/ CS/ 2018/452 Dt. 28.03.2019. Subsequently, M/s. Biswas Security Services (India) Pvt. Ltd. was also debarred from Security NIT No: IITP/Admin/SS /2018/01, Dated: 20.12.2018, vide Letter No.: IITP/Admin/Security/2018/ 459 Dt. 28.03.2019.

Subsequently, by Hon'ble High Court, Patna in the matter of CWJC 9676 of 2019, M/s. Biswas Security Services (India ) Pvt. Ltd. vs IIT Patna & others, on 07.05.2019, the order of blacklisting was kept in abeyance.

Also in another writ petition CWJC 9367 of 2019, on 08.05.2019 the Hon'ble High Court directed to put the ongoing tendering process on hold which resulted in multiple extensions to the existing firms for providing uninterrupted Housekeeping Services& Security Services.

Since the Institute was unable to float the fresh tenders for long in view of the order passed by Hon'ble Court, the legal opinion was sought from Dr. Anshuman, Institute's empaneled advocate to explore the possible options. Relevant portion of the opinion dated 09<sup>th</sup> Aug. 2020, is reproduced below:

"The said tenders are never in question rather the decision of blacklisting was in question and with the view to protect the right of the petitioner Hon'ble Court has stayed the order of Blacklisting and also directed to maintain the status-quo as contract in question was not awarded to anyone.

Since the original period of contract i.e. one year has already been lapsed so in my opinion the Institute ought to have issued fresh tender for the year 2020. This shall be correct position of law."

He further opined that the Institute should file another I.A. explaining the present position and difficulty, before the Court and seek permission to issue fresh tender but before that Institute has to withdraw the order of blacklisting unconditionally which was kept in abeyance by the Hon'ble Court.

Another legal opinion was sought from an independent advocate which was presented before the Board. Excerpt of the opinion received from Mr. Kunal Tiwary, Advocate, Patna High Court is reproduced below:

"It appears that the Hon'ble Court while clubbing both writs granted status quo to be maintained only till the next listing date of both the cases i.e. 01 July, 2019. Meaning thereby that after 1st July, 2019, the status quo order granted by the Hon'ble Courts gets automatically vacated and therefore, in the said background in my opinion there is no harm in proceeding ahead with the tender process with respect to NIT No. IITP/Admin/SS/2018/01 and NIT No. IITP/Admin/Cleaning Services/02/2018 or fresh tenders for both the services may be initiated after cancelling previous tenders as considerable period of time has lapsed since both the tenders were published in the year 2018. Participation of litigant firms will be subject to the outcome of CWJC No. 9676/2019 and CWJC No. 19371/2019".

The Board directed the institute to take appropriate administrative decision in best interest of the institute and initiate fresh tendering process at the earliest.

The Board approved the empanelment of M/s Medipark Hospital, Patna and M/s Mediversal Super specialty Hospital Patna on CGHS rates.
