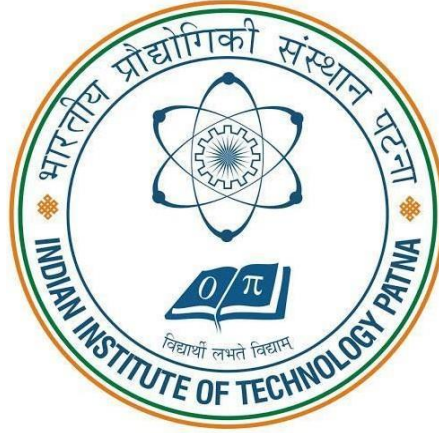

4. The interested Firms are not required to deposit any tender fees.

The interested Firms are not required to deposit any EMD amount instead of which they are to provide a signed copy of Bid Security Declaration in the format provided accepting that if they withdraw or modify their bids during period of validity etc, they will be suspended for the time specified in the tender document.

6. Bidders need not come at the time of Technical and financial bid opening at IIT Patna. They can view live bid opening after login on CPP e-Procurement Portal at their remote end. If bidder wants to join bid opening event at IIT Patna then they have to come with bid acknowledgement slip that generates after successfully submission of the online bid.

7. Scanned copy of solvency of 40% of estimated cost not older than six months from the date of publication of NIT.
8. Scanned copy of valid EPF and ESIC registration, if applicable.
